# Conditions of Entry

1. The organizing committee reserves its rights, as laid out in the wording of ESNZ Article 610.
2. All classes will be run under all applicable FEI Rules and Regulations including 2011 Rules for Eventing
3. Excessive entries and balloting as laid out in the wording of ESNZ Article 628
4. All horses are required to have either FEI passports or Official ESNZ Identification papers – FEI Article 511.
5. Competitors in classes 1—3 are reminded that riders and horses must be registered with the FEI, See Article 511
6. All horses in classes 1,2,3 and 4 must be accommodated on the grounds and must be presented for the arrival inspection prior to beginning of their event.
7. Entries will be accepted on the Official Puhinui Event Entry Form accompanied by the relevant entry fees and must be in the hands of the Secretary by 5pm Wednesday 16th November 2011. Faxed and emailed entries with entries fees paid directly to EA bank account will be accepted. (Bank account details Eventing Auckland 010170 0141658 00) All cheques should be made payable to Eventing Auckland Inc. Online entries at [www.equestriantentries.co.nz](http://www.equestriantentries.co.nz) will be accepted. ALL FEES MUST BE PAID BEFORE ENTRIES ACCEPTED
8. All scratchings must be notified immediately. Classes 1 to 3 there will be no refunds after the close of entry except refunds will be paid in full for horses not meeting the qualifying standard until 8pm Monday 28th November (post Richfields). In classes 4, 5, and 6 refunds will be paid in accordance with ESNZ Article 629 1.2. There will be no refunds for yards /camping after 29th November 2011. Requests for refunds must be in writing and accompanied by a SAE. No refunds of \$10 or less will be paid.
9. **Double Entries:** Competitors may make a double entry nominating **two horses in the same class where only one will start**. Fee of \$10 is charged for the second horse, non refundable as laid out in the wording of ESNZ Article 626.
10. All fees listed in this schedule include GST
11. Prize Money
  - a. Prize money for the FEI classes will be paid by cheque to the rider to their mail address by 31st January 2012.
  - b. All other classes will be paid in full at the conclusion of the event.
14. Qualifications – The qualification period ends on Monday 28th November 2011. Details of qualifying competitions must be included with entries. Qualifications of competitors and horses do not necessarily have to be acquired as a combination. NOTE: **Qualifying competitions must have been held since 1<sup>st</sup> January 2009**. Qualifications Criteria see FEI Article 506. Riders in classes 1,2 and 3 who have not reached the age of 18 require an Age Dispensation from ESNZ Eventing.
